

Privacy Policy – 1MB Chrome Extension

Last updated: January 2026

1. Overview

This Privacy Policy explains how 1MB (“we”, “our”, or “us”) collects, uses, and protects information when you use the 1MB browser extension (“Extension”).

We are committed to transparency and user choice. Data collection is limited, feature-driven, and controlled by the user through the Extension’s settings.

1. Information We Collect

We collect information only as necessary to provide the Extension’s user-facing functionality.

1.1 Information You Provide

- **Email address** (if you choose to sign up using email)
- Any information you voluntarily provide through the Extension interface (such as referral participation or feedback)

Providing this information is optional unless required for a specific feature.

1.2 Extension Usage Information

When you enable specific features, the Extension may process limited information such as:

- Extension feature usage (e.g., when a feature is enabled or used)
- User preferences and settings
- Participation status in rewards or waitlist programs

This information is used to ensure the Extension functions correctly and to display relevant features and notifications.

1.3 Webpage Context (User-Initiated)

When you explicitly interact with the Extension, it may access limited information about the currently active webpage, such as:

- The URL or domain of the active page
- Page context required to perform a user-requested action

This occurs only to support features you choose to use and is not performed independently of user interaction.

2. Information We Do Not Collect

We do **not** collect:

- Passwords, PINs, or security credentials
- Credit card numbers, bank details, or financial account information
- Health or medical information
- Personal communications such as emails, messages, or chat content
- Precise location data such as GPS coordinates
- Keystroke logging or hidden activity monitoring

3. How We Use Information

We use collected information to:

- Provide and operate Extension features
- Display insights, notifications, and rewards
- Manage user accounts, waitlist access, and approvals
- Improve usability, performance, and reliability

- Prevent misuse or abuse of the Extension

Information is used only in ways that are consistent with the Extension's functionality and user expectations.

4. User Control and Choice

You are always in control of your experience.

- Tracking and participation features can be enabled or disabled within the Extension
- You can adjust preferences at any time
- You can stop using the Extension or uninstall it at any time

Where features require data access, they are initiated by user action and explained within the Extension interface.

5. Data Sharing

We do not sell personal data.

We may share limited information only in the following circumstances:

- With service providers who help operate the Extension (such as email delivery or infrastructure services), under confidentiality obligations
- When required to comply with applicable laws or legal processes
- To protect the rights, safety, and security of users or the platform

Any sharing is limited to what is necessary for these purposes.

6. Data Retention

We retain information only for as long as necessary to:

- Provide the Extension's features
- Meet legal or regulatory obligations
- Resolve disputes or enforce agreements

Retention periods may vary depending on the type of information and feature usage.

7. Security

We take reasonable measures to protect information from unauthorized access, loss, misuse, or alteration. However, no method of transmission or storage is completely secure.

8. Children's Privacy

The Extension is not intended for use by children under the age of 13. We do not knowingly collect personal information from children.

9. Changes to This Policy

We may update this Privacy Policy from time to time.

If changes are made, the updated policy will be posted with a revised "Last updated" date.

Continued use of the Extension after changes indicates acceptance of the updated policy.
