## Body Discovered on Docked Vessel Near Montauk Yacht Club Prompts Police Investigation

Authorities are investigating the death of a woman whose body was found aboard a boat docked near the exclusive Montauk Yacht Club in New York. The incident was reported in the early hours of Monday, August 5, and remains under active investigation by the Suffolk County Police Department.

The body was discovered on a vessel located off Star Island Road in Montauk, a well-known luxury destination at the eastern tip of Long Island. According to a statement provided to *Fox News Digital*, detectives from the Suffolk County Police Homicide Squad were notified around 4 a.m. Tuesday morning, and are now leading the investigation.

“Suffolk County Police Homicide Squad detectives are investigating the death of a woman who was found on a boat docked off Star Island Road in Montauk on August 5,” the department confirmed. “The woman’s cause and manner of death have yet to be determined.”

The identity of the deceased has not been released, and officials have not stated whether foul play is suspected at this stage. Investigators are currently working to determine the circumstances surrounding the death.

A spokesperson for the Montauk Yacht Club acknowledged the incident but withheld additional information, citing the ongoing investigation. “We are saddened to learn of the incident that took place,” the spokesperson told *Fox News Digital*. “Our team is cooperating with law enforcement in their ongoing investigation and remains committed to the safety and well-being of our guests and staff. We have no further comment at this time.”

The Montauk Yacht Club, a high-end property catering to seasonal tourists and affluent visitors, is located in one of the more secluded and upscale areas of Long Island. Known for its marina, oceanfront accommodations, and private docks, the club has long served as a hub for yacht owners and luxury travelers, particularly during the summer months.

Star Island Road, where the boat was docked, is adjacent to several marinas and luxury resorts in Montauk, including the yacht club. The area typically sees an influx of wealthy visitors during peak travel seasons, and its exclusivity has made it a favored spot for both recreation and waterfront real estate investment.

Although no official details have been released regarding the condition of the body or any potential signs of trauma, law enforcement continues to treat the matter as an open case pending the results of a medical examiner’s report. Toxicology and forensic analysis are expected to play a central role in determining the cause and manner of death.

No timeline has been provided for when authorities might release further details. The Suffolk County Police Department has urged anyone with information about the incident to contact

the Homicide Squad directly.

As the investigation continues, the case has drawn attention in the Montauk community and among frequent visitors to the area, given its proximity to one of Long Island's most prominent waterfront destinations. Until more is known, both local authorities and the Montauk Yacht Club are remaining cautious in their public statements, focusing on cooperation with investigators and maintaining operational safety.

This incident marks a rare disruption in what is typically a quiet and highly secure environment, raising questions about safety protocols and visitor oversight in one of the region's most upscale marina settings.
