## Missing Harris Park Woman Found Safe After Police Search

Lisa Alayari, also known as Lisa Johnson, a 62-year-old woman reported missing from Harris Park, New South Wales, has been safely located, the New South Wales Police Force (NSWPF) announced. Last seen at Harris Park Train Station on July 25, 2025, at approximately 7 p.m., her disappearance prompted a week-long search by the Cumberland Police Area Command (CPAC). The NSWPF expressed gratitude to the public and media for their assistance in spreading awareness, which contributed to her safe recovery. Concerns for her welfare underscored the urgency of the effort, highlighting the critical role of community support in such cases.

The search began after Alayari could not be contacted or located, leading to a formal report to the CPAC on August 7, 2025. Described as Caucasian, 160 cm tall, of medium build, and with blonde hair, Alayari was known to frequent the Granville, Guildford, and Mays Hill areas. Police received information suggesting she may have been in Redfern on August 6, 2025, which guided their inquiries. The NSWPF issued a public appeal to locate her, emphasizing concerns for her safety due to her age and the lack of contact. The appeal was widely shared, amplifying the reach of the search effort.

The successful resolution of the case reflects the effectiveness of coordinated action between law enforcement and the community. The NSWPF's statement, as reported by local media, highlighted the importance of public vigilance in providing leads that aided the search. While specific details about Alayari's condition or the circumstances of her recovery were not disclosed, the focus remained on the positive outcome. The police's acknowledgment of media support underscores the role of timely information dissemination in missing persons cases, particularly in a busy suburb like Harris Park.

Community engagement proved vital in this case, as it often does in resolving missing persons reports. Harris Park, part of Western Sydney's diverse Cumberland region, relies on strong community ties to support such efforts. The NSWPF's appeal reached residents and media outlets, who shared descriptions and last-known locations to maximize the chances of locating Alayari. This case illustrates the broader importance of public cooperation, especially when vulnerable individuals, such as the elderly, are at risk. The lack of detail about her whereabouts during the missing period suggests a focus on privacy, with the priority being her safe return.

The NSWPF continues to encourage the public to report information promptly in similar cases, noting that even minor details can be crucial. This incident, while resolved, serves as a reminder of the challenges posed by missing persons cases and the need for robust systems to ensure swift recoveries. The Cumberland community's response demonstrates the strength of collective action in addressing local safety concerns. Alayari's safe return offers relief to her family and reinforces the value of public and media support in assisting law enforcement.

As the case concludes, the NSWPF's gratitude reflects a shared commitment to protecting vulnerable citizens. The successful outcome in Harris Park highlights the importance of maintaining vigilance and fostering cooperation between authorities and the public. This

resolution strengthens trust in local policing efforts and serves as a model for handling future cases with efficiency and care.
