## Father Killed by Wife and Her Lover, Son Shares Chilling Account in Rajasthan, India.

In a disturbing case from Alwar district, Rajasthan, an eight-year-old boy has revealed critical details surrounding the murder of his father, Hansraj, allegedly at the hands of his mother and her lover. The incident took place on August 15, 2025, in Kishangarh Bas town, sending shockwaves through the local community and raising serious concerns about domestic violence.

The boy recounted that on the night of the crime, he observed his father, mother, and the son of the family's landlord drinking together. According to his testimony, a heated argument erupted between his father and the landlord's son, escalating to physical violence. The child described how his father threatened to harm the landlord's son, prompting a retaliatory attack. After the confrontation, the boy said he was told to go to sleep. When he awoke, he found his father on the bed and soon witnessed his mother and the landlord's son moving the body. He later observed them taking his father's body to a remote location, ultimately concealing it in a blue drum at a brick kiln, from which authorities later recovered the remains.

Investigators confirmed that Hansraj's body was discovered in a blue drum at a brick kiln, not atop the rooftop of their rented residence. The boy's account has been crucial in reconstructing the events leading to the murder and identifying the individuals involved. Authorities are continuing to investigate the motivations behind the crime and the subsequent actions of the perpetrators to conceal their involvement.

Officials noted that the case bears striking similarities to a previous incident in Meerut earlier this year, where a merchant navy officer was killed by his wife and her lover, with the body concealed in a drum. These incidents have prompted renewed attention on domestic violence and the extremes some individuals may go to cover their crimes, highlighting the need for vigilance and timely intervention.

The police are gathering forensic evidence and corroborating the boy's account with other sources to build a comprehensive understanding of the crime. Child testimony in criminal investigations is being treated with

care, ensuring the young witness's safety and psychological well-being while assisting law enforcement in establishing a clear chain of events.

Local residents remain in shock over the brutal nature of the murder, struggling to process the violent acts within their community. Authorities have emphasized support services for surviving family members, particularly the children, to provide counseling and assistance in coping with the trauma. Community members have expressed concern over the safety of children and families, prompting discussions on better protective measures and awareness around domestic violence.

The Rajasthan police have assured the public that all necessary steps are being taken to bring the perpetrators to justice. Investigators continue to scrutinize the circumstances surrounding Hansraj's death, including potential motives, planning, and any accomplices involved. The case is expected to lead to stricter monitoring of domestic conflicts and enhanced measures to safeguard vulnerable family members.

As law enforcement proceeds with the investigation, authorities remain committed to transparency and timely updates for the community. The chilling account provided by the boy has become central to the case, enabling officials to pursue justice effectively while emphasizing the importance of protecting witnesses, especially minors, during complex criminal investigations.

The developments in Alwar highlight the serious consequences of domestic violence and the critical role of law enforcement and social services in responding to such crimes, underscoring the importance of vigilance, community support, and legal accountability in preventing similar tragedies.
